

Privacy Policy *commonsplace.eu*

Effective date of privacy regulations: 9 May 2025

This Privacy Policy describes:

- The information that we receive from you when you interact with us.
- Our practices for processing and protecting the information that we receive.
- Your choices regarding the collection and processing of your personal information.

This Privacy Policy applies to *commonsplace.eu* (collectively, "we", "our", "the website", or "us") operating the following websites: <https://www.commonspace.eu> and <https://karabakhspace.commonspace.eu> (collectively, "website", or "websites").

Please review this Privacy Policy carefully. By visiting our websites and submitting information to us, you consent to the collection and processing of your information as described in this Privacy Policy.

We reserve the right to modify or amend the terms of our Privacy Policy from time to time without notice. The amended Privacy Policy will be posted on *commonsplace.eu*. Your continued use of our websites following the posting of changes to our Privacy Policy will mean you accept those changes.

1. *commonsplace.eu* identity

commonsplace.eu is owned and managed by LINKS Europe Stichting and has its statutory seat in The Hague (the Netherlands) at Fluwelen Burgwal 58, 2511 CJ and is registered with the Netherlands Chamber of Commerce under No. 74113771.

2. Privacy protection

Protecting the privacy of visitors to *commonsplace.eu* is important to us. Your personal data will at all times be processed carefully and in accordance with the EU's General Data Protection Regulation and other applicable privacy regulations, and will only be used for the purpose for which it was obtained.

Below we explain what information we collect and how we use it.

3. Permission

By using the information and services on *commonsplace.eu*, you agree to our Privacy Policy and the conditions we have included in it.

4. Monitoring visitor behavior

commonsplace.eu uses the web analytics service Google Analytics to track who visits the websites, how this visitor behaves on the websites, and which pages are visited. This is common website practice because it takes information that contributes to the quality of the user experience. The information we record via cookies includes IP addresses and the pages visited. This information is kept anonymous and is not linked to other personal information.

Google Analytics

Google Analytics is a web analysis service provided by Google LLC that tracks and reports on website traffic. Google uses the collected data to track and monitor the use of our services. This data is shared with other Google services. Google may use the information collected to contextualise and personalise the advertising of its own advertising network.

You can opt-out of having your activity on *commonsplace.eu* recorded by Google Analytics by installing the Google Analytics opt-out browser add-on. The add-on prevents the Google Analytics JavaScript (ga.js, analytics.js, and dc.js) from sharing information about visit activity with Google Analytics.

5. Use of cookies

commonsplace.eu attaches cookies to visitors. We do this to collect information about the pages that users visit on our website, to keep track of how often visitors come back and to see which pages are doing well on the website. We also keep track of what information the browser shares.

What is a cookie?

A cookie is a small piece of text sent to your terminal (computer, tablet, smartphone, etc.) by our website that you visit thanks to your browser.

Cookies stored on your terminal can only be read by their issuer, who is able to recognise your terminal during their period of validity each time you access digital content containing cookies from the said issuer. A cookie does not identify you personally, only the browser on your terminal. Your browser retains it for a certain period of time and sends it back to the web server each time you connect to it.

When you use our website, depending on the preferences you have set on your mobile phone or tablet, an identifier of your mobile phone or tablet may be sent to us to track certain activities for advertising purposes.

In iOS, this identifier is called "IDFA" (ID for Advertising). In Android (Google Play), this identifier is called "AAID" (Android Advertising ID).

6. Disable cookies

You can disable cookies on *commonsplace.eu*. This is done via your browser. You can find more information on the website of your browser provider.

7. Details on newsletters

commonsplace.eu runs a number of weekly, fortnightly and quarterly newsletters. If you would like to receive our newsletters, you can voluntarily subscribe with your name and e-mail address using the link provided on our homepage. We do not share this information with, nor would we ever sell it to a third party. Furthermore, your information will not be shared with *commonsplace.eu* staff except for the creation and distribution of this newsletter.
